1. Introduction

It is considered essential that, for students to learn effectively, they need to exist in an environment which encourages this outcome. These guidelines are provided with the aim of ensuring that students are well presented, in the correct frame of mind and well prepared for every lesson.

2. Limiting the cost of our school uniform

Our school has a duty to make sure that the uniform we require is affordable, in line with statutory guidance from the Department for Education, on the cost of school uniform. We understand that items with distinctive characteristics (such as branded items, or items that require a school logo or a unique fabric/colour/design) cannot be purchased from a wide range of retailers and that requiring many such items limits parents' ability to 'shop around' for a low price.

We will make sure our uniform:

- Is available at a reasonable cost
- Provides the best value for money for Parents and Carers

We will do this by:

- Carefully considering whether any items with distinctive characteristics are necessary
- Limiting any items with distinctive characteristics where possible
- Limiting items with distinctive characteristics to low-cost or long-lasting items, such as ties, blazers and games kits
- Avoiding specific requirements for items students could wear on non-school days, such as coats, bags, and shoes
- Keeping the number of optional branded items to a minimum, so that the school's uniform can act as a social leveller
- Avoiding different uniform requirements for different year/class/house groups
- Avoiding different uniform requirements for extra-curricular activities
- Considering alternative methods for signalling differences in groups for inter school competitions, such as creating posters or labels
- Making sure that arrangements are in place for Parents and Carers to acquire second-hand uniform items
- Avoiding frequent changes to uniform specifications and minimising the financial impact on Parents and Carers of any changes
- Consulting with Parents, Carers and students on any proposed significant changes to the uniform policy and carefully considering any complaints about the policy

3. Appearance

Informal wearing of uniform is not appropriate for school. All staff and parents have a responsibility to ensure:

- a) That students leave the house appropriately dressed
- b) That they remain that way during the school day

4. Uniform

4.1 Senior School

- *Blazer with school crest*
- White shirt
- Grey V neck jumpers with maroon stripe (this is optional but no other jumper is permitted)
- Black trousers (not skinny fit or jean material) OR Black pleated skirt (knee-length)
- *School tie
- Black socks with trousers
- Black or natural colour tights or black or white socks with skirt
- Black hard leather school shoes (heel not more than 3cms high)
- Plain black or brown belts only

4.2 Junior School

• *Blazer with school crest

- White shirt
- Grey V neck jumpers with maroon stripe (this is optional but no other jumper is permitted)
- Black trousers (not skinny style) OR Black pleated skirt (knee-length, not mini)
- Summer dress with white socks
- Black knee length tailored shorts
- *School tie
- Black socks with trousers
- Black or natural colour tights or black or white socks with skirt
- Black hard leather school shoes (heel not more than 3 cms high)
- Plain black or brown belts only

(*) Mandatory RAAS branded items only available from Ellis Scott Schoolwear. Other items may be purchased from any supplier.

4.3 Summer Uniform

The headteacher may make the decision to move to summer uniform due to weather conditions. During the second half of the summer term all students will be permitted to wear summer uniform the details are outlined below:

4.4 Sports Uniform (Senior & Junior School)

4.4.1 Overview:

All PE uniforms worn for the sake of curriculum lessons, Games inclusive, must be from the school's PE uniform provider.

4.4.2 Logistics:

Students are not permitted to wear PE kit for any time other than their PE lessons unless there are specific circumstances. These will be determined by the Deputy Head (Achievement, Standards & Inclusion) in conjunction with other key staff.

Should a student attend a lesson outside of these specified circumstances in kit, there will be a sanction.

4.4.3 Uniform Description:

- Maroon/Technical t-shirt*1
- Games shirt*1
- Black Shorts OR black Skort OR black technical leggings
- Maroon sport socks or white sports socks (no patterns or lines)

4.4.4 Outerwear Garments:

For core PE any of the following items may be worn, unless otherwise stated within the lesson: hoody, mid-layer or drill top or an Akuma jacket.

For Games lessons any of the following items may be worn, mid-layer or drill top. Please note that RAAS hoodies may only be worn for specific activities at the discretion of the Head of PE.

Base layers may be worn under all PE uniforms and must be plain black.

4.4.5 Sick or Fit Still in Kit:

Should a student be unable to partake in the practical element of the lesson, they are still expected in PE uniform. This is because they are expected to undertake a different role such as coaching or officiating.

4.4.6 Sixth Form

Students should have a dress code which reflects the modern working environment. This should be respectful of culture, heritage and independence in their dress choice whilst recognising they are in a working environment. Sixth Form students must also recognise that they are role models for younger students and are expected to dress and act accordingly.

The Sixth Form Dress Code is gender neutral.

The general term for the Sixth Form Dress Code is 'Business Casual'.

Business casual includes the following:

- Smart trousers, chinos, cords, skirt, jumpsuit or dress.
- Collared shirt (short or long sleeve), roll neck or blouse (any colour).
- Blazer or jacket (optional other than for Chapel, open mornings and other events where they
 are compulsory).
- Optional jumper (not sweatshirt).
- Black or brown leather-style shoes or boots with minimal decoration.
- Ear piercings acceptable small hoops or studs. No large, hooped earrings.
- Nose piercing acceptable: studs, but no hoops. Maximum of two.
- Rings are acceptable as long as they do not impact work or safety.
- No restriction on coat type or material but not to be worn in classrooms.
- No restriction on hair style, but should be professionally acceptable.
- Hair colour allowed but should be muted.
- Clothing should be fitted appropriately.
- Clothing for PE, Drama and DT needs to be appropriate.

The following are unacceptable

- Hats and headwear, other than for specific religious reasons.
- Jeans, T-shirts, leather clothing, trainers, leggings, denim.
- Logos on clothing bigger than a postage stamp.
- Writing or graphic design.
- Hoodies, sweaters and the like are not a substitute for a coat and should not be brought to school.
- No Trainers Prohibited brands include Nike, Adidas, Puma and Reebok.

4.4.7 Safeguarding:

Like all adults on-site, Sixth Formers can expect to be challenged by staff about their presence in order to keep children safe. Part of the Sixth Form uniform includes lanyards to make them clearly visible to staff and visitors.

5. Prefects and School Council Members

These three groups of students are allowed to wear a specific tie (on award of said tie) denoting their status.

6. Jewellery

For all students in Junior or Senior School, items that do not adhere to the below guidelines will be confiscated and sanctions imposed. Further guidelines may be found in our Rewards and Behaviour Management Policy and operational procedures for returning items are shared with students and parents.

6.1 Junior and Senior school

Guidelines on jewellery apply to all students in the Junior and Senior school. The following jewellery is permitted to be worn:

- a) 1 pair of small plain metal studs, one in each lower lobe.
- b) 1 watch
- c) 1 neck chain not visible

No other jewellery or piercing is allowed. This includes any items worn as bracelets such as 'scrunchies', 'festival bands' or similar. There are times when the above items may need to be removed for certain subjects for health and safety reasons.

7. Coats

A smart coat or jacket may be worn around school. Coats, hats and scarves must be removed on entering specific locations such as classrooms, Dining Hall and assembly locations.

8. Hair and Make Up

Make up should be subtle and not obvious e.g. no green or similar eye shadow or bright lipstick. Only clear nail varnish and sensible length finger nails are permitted, no acrylic nails.

Hair must be of an appropriate style and should only be a natural colour. It may also need to be tied back for some lessons for health and safety reasons. Facial hair must be shaved or cut in an appropriate manner.

Junior School students should not wear make-up.

9. Tattoos

No student should have a tattoo visible during school time (8:00am - 3.35pm). Offensive tattoos are prohibited.

10. Appearance in School

All students should remain in uniform all day including study periods and time in boarding houses.

11. Appearance in Boarding including evening supper

Students are asked to dress appropriately and with due regard for the environment, other people and health and safety. This means they may wear home clothes and are trusted to make the right decisions. If clothing is deemed to be inappropriate, the matter will be raised discreetly by boarding staff.

12. Sanctions

Any student failing to adhere to the Uniform Policy will be sanctioned in accordance with the Rewards and Behaviour Management Policy and they may be removed from lessons, and educated in an alternative location, or sent home in order to return wearing the correct uniform.

The Headteacher and SLT will be the final arbiters in all matters.
